

## **Terminal Bonuses**

Sometimes an insurance company declares a Terminal Bonus on a Whole of Life & Endowment Assurance policy.

In these cases, they will pay the declared bonus on all contracts that are paid out on death or, in the case of Endowment Assurances, maturity in that year.

Terminal bonuses may be declared (or not) from year to year and last only for that year.
